IRS Form 2290 (Internal Revenue Service)

It is required that any vehicle that has a GVW of 55;000 pounds or more file and pay the 2290 excise tax. The tax must be filed and paid by July 31st of every year.

KYU Supplement (Kentucky Weight Distance)

KYU Number

Operating Authority:

- Per FMCSA: If a sole proprietor owner/operator submits personal information for registration purposes to obtain a USDOT Number or Operating Authority, this information will be publicly available on FMCSA Web sites. This published information may include but is not limited to, the sole proprietor owner/operator's home address, telephone number, and e-mail address when the home contact information also serves as the business contact information.
- Depending upon the type of business operation (Motor Carrier, Broker, Freight Forwarder, Shipper, Vehicle Registrant, and Cargo Tank Facility) and what will be transported (property, hazardous materials, and passengers), companies may be required to register for both Interstate Operating Authority (Form OP-1 series or Form OP-2) and USDOT Number (Form MCS-150 series). The Federal Motor Carrier Safety Administration (FMCSA) enforces compliance with the Federal Motor Carrier Safety Regulations (FMCSRs) and the Hazardous Materials Regulations (HMRs), which govern safety and financial responsibility. FMCSA's registration requirements reflect the focus on both concerns.

Oregon Weight-Mileage Tax Renewal

This package includes the following:

- Your Oregon Weight Receipt and Tax Identifier must be renewed each year by January 1st. Only accounts in good standing (all returns have been filed and tax due paid) will be renewed.
- Motor carriers operating a commercial vehicle on Oregon public highways, with a GVW over 26,000 pounds are required to have an Oregon Weight Receipt and Tax Identifier. This can be obtained at the Port of Entry on each trip, or you can apply for the permit, which expires at the end of each year.
- Oregon requires all new permit holders to obtain a bond (not included) before the permit will be issued. Once your account is set up you are required to file monthly or quarterly returns, even if no miles were running.
